Welcome to Membership of the **Kush Film Boutique** incorporating **Sidestreet Cinema**, get ready to start enjoying your special member's benefits. Here are your **Terms and Conditions**.

Terms & Conditions:

Membership covers a 1-year (12-month) period and this membership period will officially start **from the date you make full payment and sign-up to our database.**

In that membership period we will endeavour to organise a minimum of 12 film screenings under our Sidestreet Cinema and Film Boutique brand banners only (any additional events we organise that are not under these fore-mentioned brands; will not be eligible for the benefits of this membership), if for any reason we do not put on a minimum of 12 film screenings in any given 12-month period of this membership, we will take this into consideration and look at further extending your membership to make sure you are offered at least 12 screenings in your membership period (but remember its totally up to you whether you attend screenings or not when offered as they all count towards your 12 screenings total). We will always seek to make sure you are offered 12 events. But if we do organise 12 or more screenings in a 12-month period covering your membership period and you have had the opportunity of attending all those events and you personally choose not to attend some screenings, then we will not extend your membership any further. So please keep check of the amount of events/screenings offered during your 1-year membership period. At the end of 12 months your membership will expire and be due for renewal.

Member's Guest 'Film Club' Introduction Offer:

Members will be allowed to bring along and introduce our services to one (1) guest per event that guest will be charged an reduced admission fee (example: If admission for non-members is: £10 your guest will pay **£8** /if £15 then your guest pays **£13**. Member's guests will be allowed to attend only once at the reduced fee and then if they want to attend again be expected either to become a member or pay the normal admission rate.

Your new Membership card and terms and conditions will be sent out to you within 14 working days of signing up to our Membership Database and we will endeavour to make sure you have your card before the next screening date (be advised; even without a membership card you are unequivocally confirmed as a member once the required payment is received and you sign-up to the email database, so not to worry as we will have your details on record).

Membership cards must be signed upon receipt and must not be given to any other person to use. (Members abusing any of the terms and conditions will lose their membership privileges and membership may be revoked).

Cancellations: Membership must be cancelled within 14 days of making your payment .You will only receive a full refund if you have not yet attended any screenings as a member. You will not be able to cancel your membership once the 14 days expire (cancellations will incur a charge of £20 for administration purposes).
